BYLAW NO. 1994**

RATES & FEES BYLAW

A BYLAW OF THE TOWN OF FORT MACLEOD, in the Province of Alberta, to establish rates and fees for the provision of goods and services by the municipality.

WHEREAS pursuant to Section 7 of the *Municipal Government Act*, RSA 2000, c. M-26, as amended from time to time, Council has the authority to pass bylaws related to the delivery of services provided by or on behalf of the municipality, and

WHEREAS the Town provides a variety of services and supplies to the public for a fee, and

WHEREAS the *Freedom of Information and Protection of Privacy (FOIP) Act*, RSA 2000, Chapter f-25, as amended from time to time, authorizes a local public body to, by bylaw, set any fees the local public body requires to be paid under the FOIP ACT, which must not exceed the fees provided for in the regulations; and

WHEREAS Council may amend rates and fees from time to time.


NOW THEREFORE, the Council of Fort Macleod duly assembled, and under the authority of the Municipal Government Act, as amended, hereby enacts the following:

1. This Bylaw may be cited as the "Rates & Fees Bylaw"
2. That the Schedule of Rates & Fees attached to Bylaw # sets out the fees for the services and products provided by the Town of Fort Macleod.
3. That Bylaw #1937 and all amendments hereto be repealed, and
4. This Bylaw comes into force on the third and final reading.


READ a **first** time this 13th day of January, 2025.

- a residential property of 4 or more dwelling units or a non-residential property with an assessed value of \$300,000 or less	\$250.00/parcel
- a residential property of 4 or more dwelling units or a non-residential property with an assessed value of more than \$300,000	\$500.00/parcel
