



## VILLAGE OF SILVERTON BYLAW NO. 549, 2025

### A BYLAW TO AUTHORIZE THE CHARGING OF FEES FOR SPECIFIED MUNICIPAL SERVICES AND PRODUCTS

WHEREAS the *Community Charter* provides that Council may, by bylaw, impose a fee payable in respect to all or part of a service or product of the municipality;

NOW, THEREFORE, the Council of the Village of Silvertown, in open meeting assembled, ENACTS AS FOLLOWS:

**1. Title**

This bylaw may be cited as “Fees and Charges Bylaw No. 549, 2025”

**2.** Schedule “A of *Village of Silvertown Garbage Collection and Control Bylaw No. 443, 2005, as amended* is replaced with Schedule “A” of this bylaw.

**3.** Schedule “A” of *Village of Silvertown Water Rates and Regulations Bylaw No. 479, 2012, as amended* is replaced with Schedule “B” of this bylaw.

**4. Severability**

If any portion of this bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion must be severed, and the remainder of the bylaw is deemed valid.

**5. Effective Date**

This bylaw will take effect upon adoption.

READ A SECOND TIME this 12<sup>th</sup> day of February, 2025.

READ A THIRD TIME this 12<sup>th</sup> day of February, 2025.

<b>Annual Garbage Collection Charges</b>	
Single family residence	\$194
Apartments, suites or duplexes, each unit	\$194
Short term rental accommodation, each unit	\$194
Coffee shop, bakery or restaurant	\$402
Other commercial business	\$402

<b>Annual Water User Fees</b>	
Single family residence	\$701
Apartments, suites or duplexes, each unit	\$701
Short term rental accommodation - 1st room/unit	\$701
Short term rental accommodation - additional room/unit	\$86
Coffee shop, bakery or restaurant	\$1,075
Coin laundry, 1st machine	\$845
Coin laundry, additional machine	\$104
Other commercial business	\$845

<b>Water Connection Charges</b>	
Service connection charge (maximum 1" service)	\$1,481 ***

\*\*\*The owner shall also pay for all materials, labour, equipment, supervision and administration (15%) required to install or upgrade a connection and repair road and sidewalk surfaces disturbed by the installation.
