

**WHEATLAND COUNTY
BYLAW # 2026-07**

A BYLAW of Wheatland County, in the Province of Alberta, to establish fees for providing various municipal goods and services.

WHEREAS the Council of Wheatland County has the authority to charge fees for various municipal goods and services in accordance with the Municipal Government Act, R.S.A. 2000, c. M-26 (the "Act"); and

WHEREAS Council desires to establish fees for various municipal goods and services in Wheatland County, which are set out in Schedule "A" of this Bylaw;

NOW THEREFORE, the Council of Wheatland County enacts as follows:

Title

1. This Bylaw may be cited as the "*Master Schedule of Fees Bylaw*."

Purpose

2. To establish a standardized schedule of fees for municipal services to ensure consistency, and fairness for residents and businesses.

Schedule of Fees

3. The fees and charges for municipal services are outlined in *Schedule A*, attached to and forming part of this Bylaw.

Transitional

4. That Bylaw 2025-31 is hereby rescinded.
5. This Bylaw comes into force on the day it is passed.


