BYLAW 001-2023 BEING A BYLAW OF THE TOWN OF ATHABASCA, IN THE PROVINCE OF ALBERTA, TO PROVIDE FOR THE OPERATION OF OFF-HIGHWAY VEHICLES WITHIN THE CORPORATE LIMITS OF THE TOWN OF ATHABASCA

WHEREAS Pursuant to Section 7 of the *Municipal Government Act*, R.S.A. 2000, c. M-26, a Council may pass a bylaw for municipal purposes respecting wild and domestic animals and activities in relation to them; and

WHEREAS Pursuant to Section 120 (5) of the *Traffic Safety Act*, R.S.A. 2000, c. T-6, a bylaw may prescribe terms and conditions for Off-Highway Vehicles, including speed limits and routes; and

WHEREAS the Council of the Town of Athabasca now deems it necessary and expedient to establish regulations in relation to the use of Off-Highway Vehicles within the limits of the Town.



NOW THEREFORE, THE COUNCIL OF THE TOWN OF ATHABASCA, IN THE PROVINCE OF ALBERTA, DULY ASSEMBLED, ENACTS AS FOLLOWS:

SHORT TITLE

This Bylaw will be cited as the "Off-Highway Vehicle Bylaw".

REGULATIONS

1. No person shall operate an off-highway vehicle within the limits of the Town of Athabasca.
2. Notwithstanding 1. above, snow vehicles will be permitted subject to the following:
 - a) Snow vehicle are to be operated on the designated route, as attached to and forming a part of this bylaw as Schedule "A".
 - b) Transporting the vehicle to and from the designated route shall be done by the shortest and most direct route.
 - c) The designated route shall only be used during the hours of 7:00 a.m. and 11:00 p.m.
 - d) No person operating a snow vehicle shall exceed a speed of 30 kilometers per hour within the limits of the Town.
 - e) All rules and regulations as prescribed in the Traffic Safety Act must be adhered to at all times.
 - f) Operators of snow vehicles use the designated route within the Town limits at their own risk.
3. Any person who contravenes this Bylaw, in any part, shall be subject to a fine of \$150.00 for the first offence and \$200.00 for the second or subsequent offence. Fines under the Traffic Safety Act are also in effect.


