## CORPORATION OF THE VILLAGE OF MCBRIDE

### BYLAW NO. 843, 2026

A BYLAW FOR THE PURPOSE OF LEVYING RATES FOR MUNICIPAL, HOSPITAL AND REGIONAL DISTRICT PURPOSES FOR THE YEAR 2026.

The Council of the Corporation of the Village of McBride, in open meeting assembled, enacts as follows:

1. The following rates are hereby imposed and levied for the year 2026.
  - a. For all lawful general purposes of the municipality on the assessed values of land and improvements taxable for general municipal purposes, rates appearing in column "A" of the Schedule "A" attached hereto and forming a part thereof.
  - b. For the purposes of the Fraser-Fort George Regional Hospital District on the assessed values of land and improvements taxable for hospital purposes, rates appearing in column "B" of the Schedule "A" attached hereto and forming a part thereof.
  - c. For the purposes of the Regional District of Fraser-Fort George on the assessed values of land and improvements taxable for regional district purposes, rates appearing in column "C" of the Schedule "A" attached hereto and forming a part thereof.
2. The minimum amount of taxation upon a parcel of real property shall be one dollar (\$1.00).
3. This Bylaw may be cited as "**VILLAGE OF MCBRIDE MUNICIPAL PROPERTY TAX RATE BYLAW NO. 843, 2026.**"
4. If any portion of this bylaw is declared ultra vires by the Court of Competent Jurisdiction, that portion shall be deemed to be severed from the bylaw to the extent that the remainder of the bylaw shall continue in full force and effect.
