

SUMMER VILLAGE OF LAKEVIEW

BYLAW #01-2026

A BYLAW TO AUTHORIZE A SPECIAL TAX CHARGE TO BE LEVIED AGAINST ALL TAXABLE PROPERTY WITHIN THE SUMMER VILLAGE OF LAKEVIEW FOR THE 2026 TAXATION YEAR

WHEREAS the Summer Village of Lakeview has prepared and adopted detailed estimates of the cost of the specific service or purpose and included that estimate in the budget for 2026; and

WHEREAS, the estimated amount required for the cost of the specific service or purpose is \$6,275.00; and

WHEREAS the Summer Village of Lakeview deems it fair and equitable to charge taxable properties within the Summer Village of Lakeview that will benefit from the specific services and purposes; and

WHEREAS the Summer Village of Lakeview is authorized to pass a special tax bylaw under the Municipal Government Act RSA 2000 Chapter M-26, Part 10 Division 5; and

NOW THEREFORE, the Council of the Summer Village of Lakeview, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following special tax rate on each taxable property within the corporate limits of the Summer Village of Lakeview.
 - a) 2026 Special Tax Required is \$3,675.00 for the costs of the service and purposes as follows:
 - Fire Prevention Services Tax - \$3,675.00
 - b) That the amount payable per taxable property as a special tax shall be an amount of \$75.00 levied in 2026 equally on all 49 taxable properties within the corporate limits of the Summer Village of Lakeview.
2. That the Chief Administrative Officer is hereby authorized to levy the following special tax rate on the following taxable properties within the corporate limits of the Summer Village of Lakeview.
 - c) 2026 Special Tax Required is \$2,600.00 for the costs of the service and purposes as follows:
 - Recreational Services Tax - \$2,600.00
 - d) That the amount payable per taxable property as a special tax shall be an amount of \$200.00 levied in 2026 equally on the following properties, identified by roll numbers, within the corporate limits of the Summer Village of Lakeview.
 - Roll Numbers 207, 208, 209, 211, 212, 213, 214, 216, 217, 220, 223, 301, and 302.
3. That the "Special Tax" shall levied and included on the 2026 Tax Notice and is a debt due to the municipality known as the Summer Village of Lakeview and is payable August 31, 2026.

4. That this BYLAW shall come into force and effective for 2026 taxation on the date of the third and final reading.

Read a third and final time this 28th 1st day of May 2026.
