MAYERTHORPE FOR THE 2026 YEAR**

WHEREAS, the Town of Mayerthorpe has prepared and adopted detailed estimates of municipal revenue, expenses and expenditures as required, at the regular Council Meeting on

December 8, 2025, amended April 27,
2026

WHEREAS, the estimated municipal revenues from all sources other than property taxation total

and;

WHEREAS, the estimated municipal expenses (excluding non-cash items) set out in the annual budget for the Town of Mayerthorpe for

2026 total

\$4,146,886.00

and the

balance of

\$1,901,717.03

to be raised by general municipal property taxation, and

WHEREAS, the estimated amount required for principal payment of outstanding debentures to be

raised by general municipal taxation is \$211,480.99

THEREFORE, the total amount to be raised by general municipal taxation is \$2,113,198.02




WHEREAS, the assessed value of all taxable property in the Town of Mayerthorpe, as shown on the assessment roll, is:
